## **Introduction**

We at Thinkstruct know you care about how your personal information is used and shared, and we take your privacy seriously. This Privacy Policy (the “Policy”) helps you understand how we handle personal information. By using or accessing the Thinkstruct website and related services (the “Services”) in any manner, you acknowledge that you accept the practices and requirements outlined in this Policy, and you hereby consent that we will collect, use, and share your information in the following ways.

## **Information Collected**

We collect certain information in order to facilitate your use of Thinkstruct.

### **a. Voluntarily disclosed information**

When you use Thinkstruct, you will have the opportunity to provide us with some information directly. We may collect information you directly give us as you build your profile, such as your current employer and position and the field of research you are engaged with. These fields are completely optional and if not shared Thinkstruct will not have access to this information.

In addition, we receive information submitted by you through your use of and interaction with the Services, such as prompts or inputs (“Personal Information”).

### **b. Automatically collected information**

Whenever you interact with our Services, we automatically receive and record information from your browser which may include your IP address, geolocation data, device identification, “cookie” information, the type of browser you’re, or the page or feature you requested. We may retain this information for security and analytics purposes.

Some of this information, such as cookies, may be stored on your device. It may be possible to refuse to accept cookies by activating the appropriate setting. However, if you select this setting you may be unable to access certain parts of the Services.

### **c. Information provided by third parties**

Thinkstruct may engage with third party service providers that may collect information about you, including services that are required to register for a Thinkstruct account or process payments on our behalf (“Third Party Services”). In order to do so, you will authorize the Third Party Service to share certain content and/or information with us. Please note that the specific information of yours that is transmitted from any Third Party Service to us is governed by the agreement(s) you have with that Third Party Service.

## **Use of Collected Information**

We use information that we collect about you or that you provide to us, including any personal information to provide service to you, develop and maintain Thinkstruct, and comply with legal obligations provided that you offer your consent.

We may communicate with you via email to verify your account, notify you about certain activity on Thinkstruct, inform you of changes to our policies and procedures, or to otherwise facilitate the operations of Thinkstruct.

## **Disclosure of Information**

Any queries or inputs used while navigating the Services are subject to viewing and usage by our third-party partners. Our partners may utilize this data for additional purposes, such as training or improving their artificial intelligence models.

We may de-identify your Personal Information so that you are not identified as an individual and provide that information to our partners. We may also provide aggregate usage information to our partners for business purposes.

If we (or our assets) are acquired, or if we go out of business, enter bankruptcy, or go through some other change of control, Personal Information could be one of the assets transferred to or acquired by a third party.

We reserve the right to disclose any information that we believe [in our sole discretion] is necessary to comply with law or court order; enforce or apply our [Terms of Service](#) and other agreements; or protect the rights, property, or safety of Thinkstruct, our employees, our users, or others.

## **Data Security and Storage**

Thinkstruct, has implemented measures designed to protect your personal information from loss, unauthorized access, and alteration. Thinkstruct's third-party partners also take steps to ensure the safety and security of user data contained within their platforms.

We endeavor to protect the privacy of your account and other personal information we hold in our records and actively work to prevent unauthorized entry or use, hardware or software failure, and other factors that could potentially compromise security of user information. While this endeavor we do pursue it is important to be aware that there is no such thing as perfect security.

## **Modification/Deletion of Information**

You may access, and in some cases, edit or delete, certain Personal Information we retain about you, such as your profile information. However, some information, including information related to payments or Account information and data from and concerning third party login accounts are not subject to Thinkstruct's control or modification.
